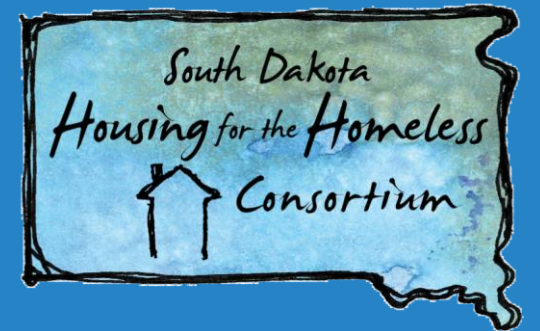

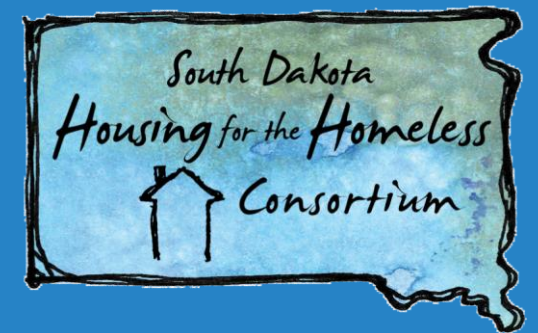

Quick Background.....

What is CoC?

- ✓ Continuum of Care, philosophy promoted by US Dept. Housing & Urban Development (HUD) to end homelessness by community collaboration
- ✓ Supported by competitive HUD CoC funding
- ✓ Organized community response
- ✓ Promote HUD “best practices approaches”

2022 CoC Competition

Tribes & CoC Funding

2021 CoC NOFO – Eligible Applicants

2022 CoC NOFO – May claim their geography & form COC, Tribes may join existing CoCs, Tribes may form new cooperative COCs, formula funding provided via HUD based on geography



CoC Responsibilities

- Operating: CoC Governance, local consultation, establishing performance targets, establish, & follow written standards for providing CoC assistance, establishing & operating a Coordinated Entry System
- HMIS: Must designate & operate a Homeless Management Information System (HMIS) designating a single HMIS Lead & manage & Ensure that it is administered in compliance with HUD requirements
- CoC Planning: Development of comprehensive housing, & service system, plan & conducting Point-In-Time Counts
- Developing a VAWA emergency transfer plan



CoC Responsibilities

Collaborative Applicant

- Eligible applicant designated by CoC to collect/submit required CoC Application info for all projects CoC has selected for funding
- Apply for CoC Planning funds on behalf of CoC. Design, operate, & follow a process for development & approval of project applications in response to the NOFO
- Establish funding priorities for the local application process
- SDHDA SD-500 CoC Collaborative Applicant



CoC Responsibilities

HMIS Lead

- Eligible applicant designated by CoC to manage CoC's Homeless Management Information System (HMIS)
- Policies & Procedures for HMIS including data quality management, training, system maintenance, reporting



CoC Responsibilities

CoC Governing Board

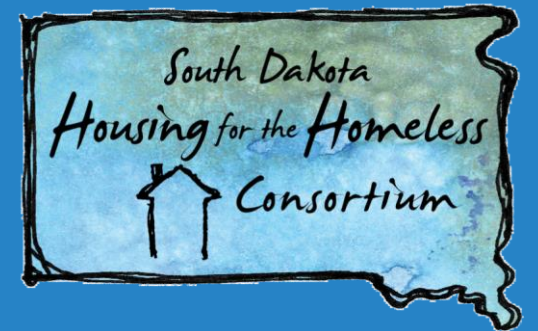
- Collective of individuals designated to provide oversight & governance on behalf of the CoC
- The CoC Board must be representative of the relevant organizations & of projects serving homeless populations & subpopulations within the CoC's geographic area.



CoC Responsibilities

CoC Recipient

- An applicant of CoC Program funds that executes a grant agreement with HUD for those CoC Program funds



CoC 2022 Program Plans

- During registration, Collaborative Applicants review available geographies, confirm which are claimed as part of the CoC's geographic area
- HUD will publish Geographic Codes with Preliminary Pro Rata Need (PPRN) amounts for all formula areas (including reservations or trust land) available to be assigned to CoCs during FY22 Registration process.
- A Tribal resolution is required to permit an existing CoC to claim reservation or trust land as part of the CoC's geography (not required for Tribes or TDHEs).



CoC 2022 Program

What does this mean for Tribes and TDHEs?

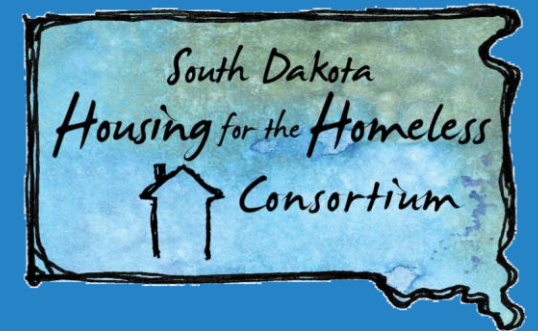
- Tribes or TDHEs may serve as Collaborative Applicants for an existing CoC
- Tribes or TDHEs may register as Collaborative Applicants & claim geographic areas in their formula areas
- An existing CoC can elect not to select previously-claimed geographic areas that includes a portion of a Tribe's formula area so a Tribe or TDHE may serve that geography under a newly-formed CoC



CoC 2022 Program

What else does this mean for Tribes and TDHEs?

- Existing CoCs may claim geographic areas in formula areas (with Tribal resolution) in areas where a Tribe, TDHE, or other eligible entity intends to apply for projects through an existing CoC.
- A Tribe or TDHE may approve the subdivision of trust land or reservation among more than one CoC (including an existing CoC or CoC newly formed by the Tribe) through a Tribal resolution



CoC Introduction

CoC Application Process

- The Continuum of Care establishes a local competition to rate & rank projects
- Applicants submit a project application to their CoC & the CoC either rejects it or accepts & ranks it based on the rating & ranking process
- The CoC submits a CoC application & all project applications to HUD for review
- HUD reviews project applications to ensure they meet threshold requirements & scores the CoC applications
- Project applications can be funded based on a combination of CoC score & how the CoC ranked the project



CoC Project Types

Permanent Supportive Housing (PSH)

- Must include disabled household member, typically adult head of household
- Lease required & must be for a term of at least one year, renewable
- May be single site, scattered sites or clustered, & can integrate with affordable or market-rate units
- Services must be offered, may vary depending on the needs
- Dedicated & Dedicated PLUS PSH include additional requirements related to length of time homeless & where participants need to have resided

Rapid Re-housing (RRH)

- Funds may be used to provide supportive services & short- or medium-term tenant-based rental assistance.
- Projects may provide a maximum of 24 months of rental assistance.
- Lease required for all PH: RRH & must be for a term of at least one year



CoC Project Types

Transitional Housing (TH)

- All program participants must sign a lease, sublease or occupancy agreement for a period of at least one month.
- Leases/occupancy agreements renewable upon expiration, except on prior notice by either party, with a maximum term of 24 months.
- Must provide access to supportive services the entire time participants reside in TH
- Services may also be provided to former TH residents for up to six months after leaving TH

Joint Transitional Housing-Permanent Housing - Rapid Re-housing (RRH-TH)

- Must offer both transitional housing & rapid rehousing. Not everyone needs to be enrolled in both
- TH portion has the same requirements as project with only TH
- RRH portion has the same requirements as project with only RRH



CoC Project Types

Support Services Only – Coordinated Entry (CE)

- CoC is required to have in place a CE
- CE includes processes for Access, Assessment, Prioritization, & Referral
- All CoC & ESG permanent housing solutions are required to flow via CE
- All ESG Homeless Prevention services flow via CE

Homeless Management Information System (HMIS)

- CoC data requirements
- HUD required report (Project APR, LSA, etc.) generation
- * 25% match required for all CoC Project Funding

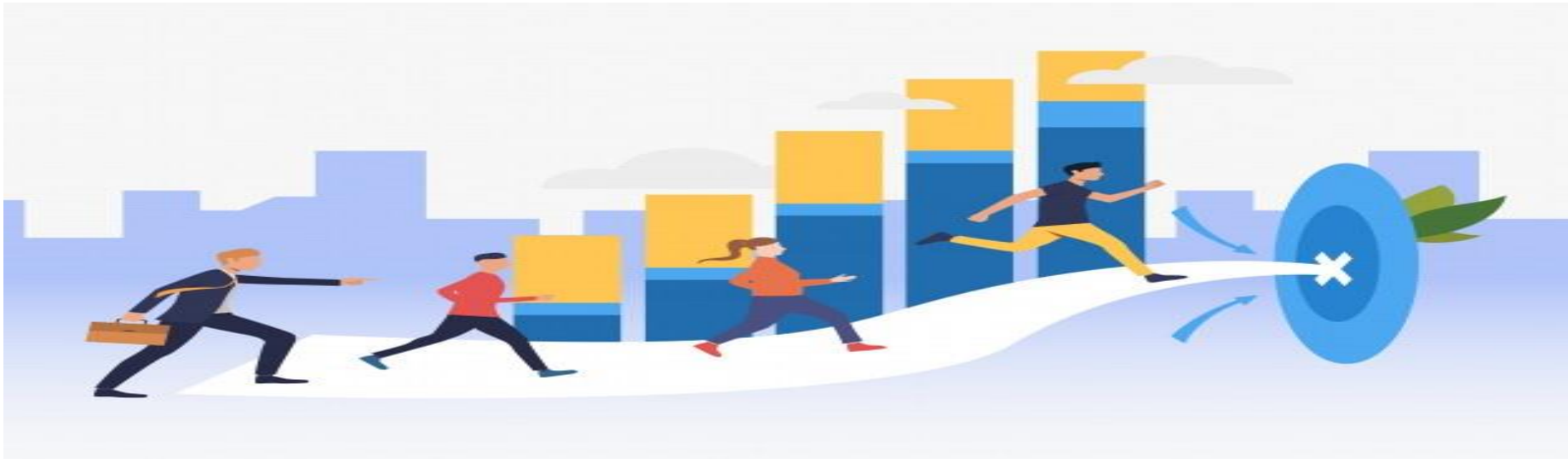
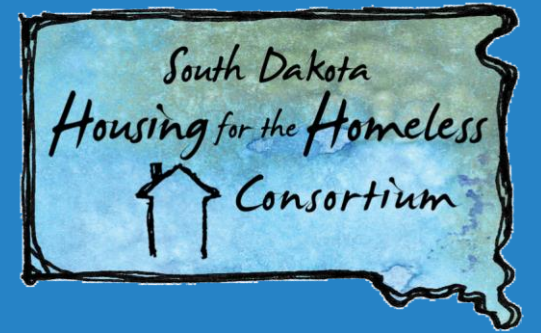

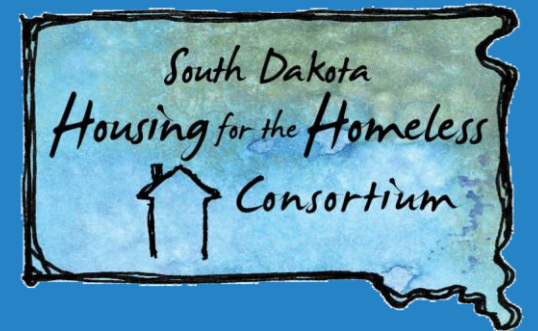

Why do we do a PIT Count?



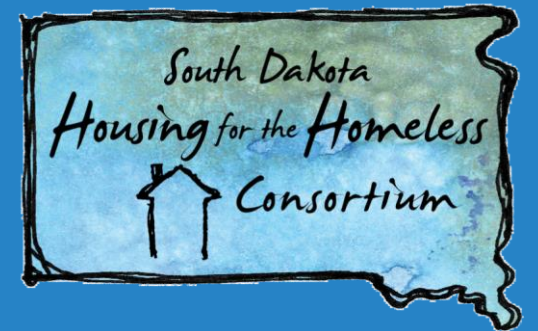
To measure & monitor trends & changes on local & national levels



To help understand what resources we need & strategize the best ways to use them to end homelessness



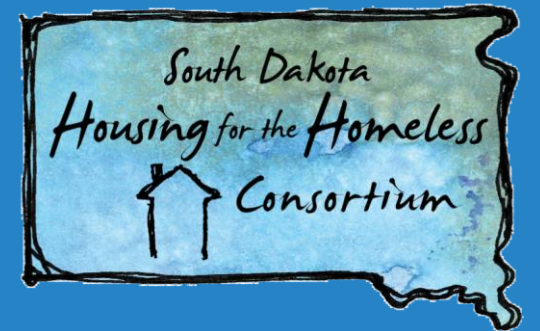
To comply with federal regulations & requirements



Point-In-Time Count

HUD Definition of Literally Homeless – Summary

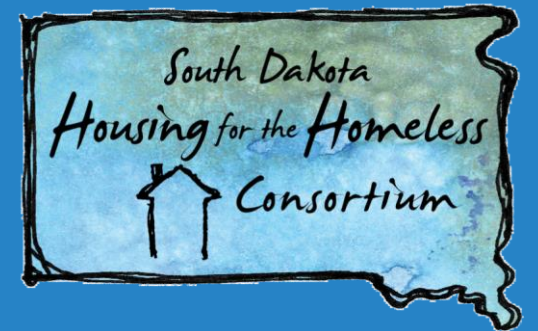
- Primary night time residence is a public or private place not meant for human habitation
- Sleeping at a public or privately operated shelter



Point-In-Time Count

Literally Homeless – Summary Continued...

- Exiting an institution where they have resided for less than 90 days and resided in an emergency shelter or place not meant for human habitation prior to institution
- Fleeing/attempting to flee domestic violence/Human Trafficking has no other residence, lacks resources to obtain other permanent housing



Sleeping Situations Surveyed

Sheltered PIT Count

- Emergency Shelters, Hotel Vouchers provided by non-profits, charities, government
- Transitional Housing programs for homeless

Unsheltered PIT Count

- Car, park, abandoned building
- Campground, parking lot
- Sleeping situations in homes, RVs, & campers lacking at least one these essential items; heat, electricity, water, sewer, toilet, cooking or bathing area
(not meant for human habitation)

Who should not be counted?

- Situations in which persons should not be counted for PIT Count
 - Jails
 - Detox
 - Hospitals
 - Wards of the state or tribe
 - Foster children
 - Doubled-up or couching surfing
 - People paying for their own housing



Point-In-Time Count

SD Domestic Violence, Human Trafficking Agencies & PIT Count

- PIT Count ensures confidentiality, & safety
- DV agencies are contacted directly by SDHDA
- Davis will assist DV agencies by appointment



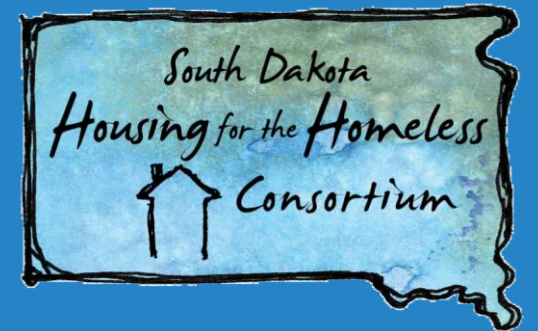
PIT Count & Racial Disparity

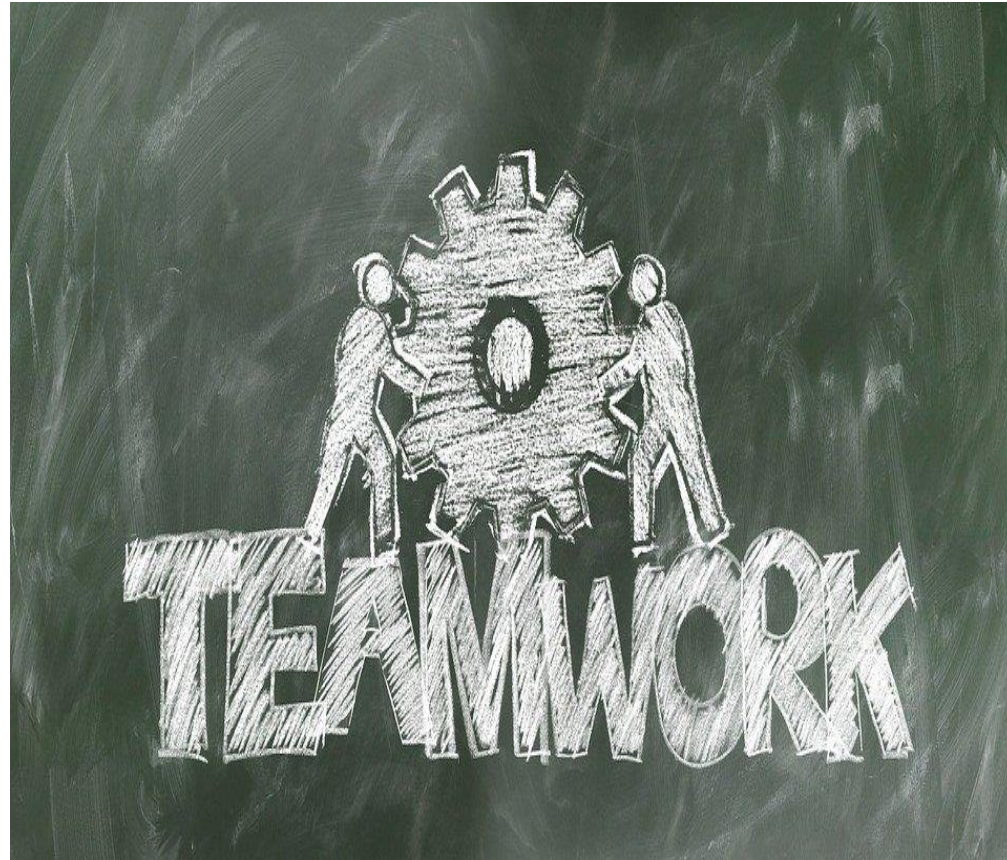

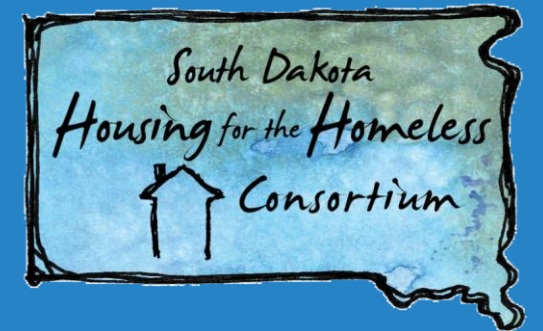
